SECOND DRAFT OF THE 2024-2025 BUDGET

Superintendent Chamberlain and School Business Administrator Hartshorne provided a second draft of the 2024-2025 budget. Information included revenues and expenses; the proposed budget of \$44,147,571; the current status; and requests. Discussion followed.

APPROVAL OF CAPITAL PROJECT PROPOSITION

PROPOSITION: Shall the Board of Education construct alterations and improvements to the buildings, playgrounds, athletic fields and courts and parking areas at Mannsville Manor Elementary School, Maynard P. Wilson Elementary School, Bus Garage at Maynard P. Wilson Elementary School and Middle/High School and Maintenance Building, including an addition to the Maintenance Building, all of the foregoing to include related site work and improvements, original furnishings, fixtures, equipment, machinery and apparatus required for such purposes, architectural fees, and all other necessary costs incidental to such work at a total estimated cost not to exceed \$17,100,000, and obtain the necessary funds by using \$1,000,000 from the District's reserve fund and, for the balance, the levy of a tax upon the taxable property of the School District which is hereby voted for the Project in the amount of \$16,100,000 to be collected in annual installments in the years and in the amounts as the Board of Education shall determine in accordance with Section 416 of the Education Law, and in anticipation of such tax shall the School District be authorized to issue up to \$16,100,000 of obligations of the School District; and

WHEREAS, the South Jefferson Central School District (the "District"), is a local agency pursuant to the New York State Environmental Quality Review Act ("SEQRA"), Environmental Conservation Law Section 8-0101, et seq., and implementing regulations, 6 NYCRR Part 617 (the "Regulations"); and

WHEREAS, the Board of Education determined by Resolution adopted October 12, 2022 that the Project is an Unlisted Action under 6 NYCRR § 617.5(c) of the Regulations which will not result in any significant adverse environmental impacts; and

WHEREAS, the costs of the Project have increased and the Board of Education proposes to increase the authorized cost (but not the approved scope) of the Project; and

BE IT RESOLVED by this Board of Education as follows:

<u>Section 1</u>. The proposition hereinafter set forth is hereby authorized to be submitted for the approval of the qualified voters at the annual school district election to be held in said District on May 21, 2024.
